EMERGENCY PROCEDURES FOR EMERGENCY ADVICE CALL (0508) 299299

IF THIS HAPPENS	DO THIS
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Call the emergency services on 111.
Spill or leak	Eliminate ignition sources and naked lights. Use non-sparking tools. Wear PVC overalls, chemically-resistant gloves, facemask or goggles. Prevent further spillage. Do not flush with water. Shovel & sweep up spilled material and place in a sealed container for disposal. If spilled onto soil near valuable trees, remove top 50mm of soil after cleanup. Refer to the product label or local authority for disposal advice.
Fire	Call the Fire Service on 111. Keep non-involved persons clear. Wear PVC protective clothing and breathing apparatus. Toxic fumes may be released by fire. Extinguish fires using foam, dry chemical or carbon dioxide. Contain extinguisher run-off and treat as for Spillage above.

FIRST AID

If swallowed	DO NOT induce vomiting. For advice contact a doctor or the National Poisons Centre on 0800 POISON (0800 764766).
If in eyes	Hold eyelids apart and flush continuously with running water for at least 15 minutes. Get medical attention.
If on skin	Remove contaminated clothing, flush skin with running water. Do not scrub skin.
If inhaled	Remove affected person to fresh air. If not breathing give artificial respiration, preferably mouth-to-nose. Get medical attention for any symptoms that develop.
