## EMERGENCY PROCEDURES FOR EMERGENCY ADVICE CALL (0508) 299299

### IF THIS HAPPENS

### DO THIS

#### Tanker/Vehicle Accident

Switch off engine and electrical equipment. Keep people away, warn other traffic. Call the emergency services on 111.

#### Spill or leak

Eliminate ignition sources and naked lights. Use non-sparking tools. Wear PVC overalls, chemically-resistant gloves, facemask or goggles. Prevent further spillage. Do not flush with water. Shovel & sweep up spilled material and place in a sealed container for disposal. If spilled onto soil near valuable trees, remove top 50mm of soil after cleanup. Refer to the product label or local authority for disposal advice.

#### Fire

Call the Fire Service on 111. Product is not a fire or explosion hazard. Keep non-involved persons clear. Wear PVC protective clothing and breathing apparatus. Extinguish fires using foam, dry chemical or carbon dioxide. Contain extinguisher run-off and treat as for Spillage above.

## FIRST AID

#### If swallowed

DO NOT induce vomiting. For advice contact a doctor or the National Poisons Centre on 0800 POISON (0800 764766).

#### If in eyes

Hold eyelids apart and flush continuously with running water for at least 15 minutes. Get medical attention.

#### If on skin

Remove contaminated clothing, flush skin with running water. Do not scrub skin.

#### If inhaled

Remove affected person to fresh air. If not breathing give artificial respiration, preferably mouth-to-nose. Get medical attention for any symptoms that develop.
